Tuition & Fee Schedule 2024-2025 School Year *Pre K through 8th Grade*

The Tuition Cost for Basilica School of St Paul is \$8,200.00 K – 8th Grade

<u><i>Returning Family Registration Fee</i></u>	\$100.00 per family due at time of registration
<u><i>New Family Registration Fee</i></u>	\$125.00 per family due at time of registration
<u><i>Instructional Fee</i></u>	\$250.00 per student due in August or can be added to the monthly tuition payment plan.
<u><i>Technology Fee</i></u>	\$250.00 per student due in August or can be added to the monthly tuition payment plan.
<u><i>Graduation Fee</i></u>	\$50.00 per student due at time of registration

FEES are non-refundable.

PAYMENT OPTIONS

OPTION A: \$820.00 per child. 10 Tuition Payments July-April

OPTION B: \$7,954.00 per child. **Tuition paid in full** at the time of registration by July 31st directly to the Basilica School of St Paul.

SCHOLARSHIPS

Scholarship funds are available through *Step Up for Students (SUFS)*, *Florida Empowerment Scholarship Educational (FES-EO)* and *Florida Empowerment Scholarship for Students with Unique Abilities (FES-UA)*. **Please note these Scholarships may not cover the full tuition. In this case, parents are responsible for the difference.** If a family is not eligible for any of the above scholarships, please reach out to our enrollment specialist to discuss other options.

Preschool

\$6,000.00 per child

Students with an *Early Learning Coalition* Child Eligibility Certificate will receive **VPK** credit for the **VPK program**. Please note to qualify for this program regular attendance is required. Excessive absences will result in withdrawn from the program.

Annual FACTS Enrollment Fee (non-refundable)

As per Diocesan mandate, all families must enroll in the FACTS management system. Tuition and Before/Aftercare payments are processed via FACTS. One FACTS management account per family is required, you have two options: Option A- one-time fee of \$42 for 3-10 payment plans or \$15 for 1-2 payment plans. FACTS automatically adds this fee to your tuition fee bill. Payments are made through FACTS on the 5th or 15th of every month. There is no fee if paid in full.

AFTER CARE for 2024-2025 School Year

After Care: Mullaly Hall..... 3:20 pm – 5:30 pm (Wed 2:20 pm – 5:30 pm)

Fee: \$150.00 per month, per child. **After 5:30:** late pick-up fee of \$25.00 per child.

Privilege to After Care will be terminated after the second late pick-up, without prior notice.

Terms: Charges are posted to FACTS account – Payments must be made at the beginning of every month.

Past Due Accounts: Accounts past due more than 15 days will be assessed a late fee of \$10.00 Or 2% of the outstanding balance, whichever is greater.

NOTE TO PARENTS: All children, who are not enrolled in the After Care Program, and are not picked up by 3:30 pm in the car line, will be automatically charged a late pick-up fee of \$25.00.

Please Note:

- All Scholarships ACH Payments must be approved by parents within three days of notification.
- In the event financial obligations are not met all student records will be retained and online grade access will cease until the financial obligation is fulfilled. This may also result in that the students will not be allowed on campus until the balance is paid in full.
- All scholarship letters must be submitted by July 29th.
